RECITALS

- A. Bull Mountain Estates Home Owners Association ("Association") is a Homeowners Association located in Washington County, Oregon. The Association is governed by the following documents, recorded in the Deed Records of Washington County, as they have been amended and supplemented from time to time:
 - 1. Bull Mountain Estates Covenants, Conditions Restrictions and By-Laws (the "Declaration") recorded November 7, 1997 as Document 97108272.2 in the records of Washington County, Oregon.
 - 2. First Amendment to the By-Laws of Bull Mountain Estates Home Owners Association recorded November 29, 2017 as Document 2017-093681 in the records of Washington County, Oregon.
 - 3. First Amendment to the Bull Mountain Estates Covenants, Conditions, Restrictions and Bylaws of Bull Mountain Estates Home Owners Association

recorded November 29, 2017 as Document No. 2017-093680 in the records of Washington County, Oregon.

III. Article V, Section 5.5 of the Bylaws is amended to read as follows:

5.5 **Nomination of Directors.** Nomination for election by members to the board of directors may be made by any association member. Nomination may also be made from the floor at the annual meeting.

IV. Article VI, Section 6.1 of the Bylaws is amended to read as follows:

6.1 **Regular Meeting.** The board of directors may establish the date, time and place for regular meetings of the board.
